


## **Description of Change:**

### Previous communication:

Cypress announces the removal of the Cypress logo and any trademark statements on the shipping boxes. This is to align Cypress shipping boxes with the current Infineon packaging standards. In addition, the removal of the Cypress logo provides additional security during shipment. There are no changes to ordering part numbers. Product datasheets remain the same and can be downloaded from the Cypress website (www.cypress.com).


